CAKE Bank Account Discussion: Zelenak in discussion with accountant services and other CDs to research best practices

Torch Lake RV Park update: The case against Torch Elk Skegemog Alliance v Brewer and ACD has received Stipulation and Order from Judge Power so the Brewers can work to stabilize the property and the ACD can close the permit. ACD attorney Bensinger states that the file will remain open with the legal office until the permit is closed. The ACD will monitor this site per usual until the site is stabilized and the permit is closed.

ACD Mini-grant consideration: Zelenak presented discussion to the board about providing mini-grants to municipalities and potentially non-profit groups to help with projects such as rain garden installation, recycling, or other smaller projects. More research to follow.
