**New Business:** Move regular meetings to 4<sup>th</sup> Wednesday of the month, *motion by Gosnell, second by McSweeney, motion carries 5-0;* Soil Erosion Permit Extension, ACD to present to the county Board of Commissioners a request in the future to have the ability to extend a permit for 2 years, *motion by Wolff, second by Johnson to motion carries 5-0;* Move the ACD Annual Meeting to the last Wednesday in July, the 26<sup>th</sup> in 2023, *motion by Wolff, support by Gosnell, motion carries 5-0;* Board of Directors election advertising to start in May; CAKE-CISMA to purchase a work truck using grant funds secured by CAKE-CISMA, *motion by McSweeney to approve expenditure of up to \$30,000 for, second by Wolff, motion carries 5-0;* Approval of CAKE-CISMA and ACD MOU, *motion by McSweeney, second by Johnson, motion carries 5-0.* 

**Old Business:** Insurance for part time employees in discussion, the insurance company reports that the board must vote to change the organization personnel manual to reflect the change; Transfer funds to MI Class, pending further information.

**Roundtable:** Johnson would like to see if the ACD can assist with recycling boat covers from boats after they're taken out of storage. Zelenak reports that Emmet County does take that recycling and that we can collect for people and transport but the ideal situation is to consult with marinas to see if how the ACD can partner with them to take care of the boat plastic. Zelenak to look into the SOM program and report back to the board in the future.
